THE SOUTH JACKSONVILLE RURAL FIRE DEPARTMENT PROVIDES SUBSCRIPTION FIRE PROTECTION SERVICE WITH A \$50.00 ANNUAL FEE TO CUSTOMERS WHO RESIDE OUTSIDE THE CORPORATE LIMITS OF THE VILLAGE OF SOUTH JACKSONVILLE TO THE WEST, SOUTH AND EAST.

CUSTOMERS WHO LIVE SOUTH OF ROUTE 36 (MORTON AVENUE), NORTH OF MAIN STREET IN WOODSON, EAST OF THE SCOTT COUNTY LINE AND WEST OF PISGAH ROAD ARE ALSO ACCEPTED, WITH A FEW EXCEPTIONS WHO ARE GRAND-FATHERED IN.

THE ANNUAL \$50.00 SUBSCRIPTION FEE IS DUE BY MAY 1ST OF EACH YEAR, WHICH IS ALSO THE BEGINNING OF THE FISCAL YEAR. BEGINNING NOVEMBER 1ST, THE \$50.00 FEE IS PRO-RATED PER MONTH THROUGH APRIL 30TH.

DURING 2010, ALL INFORMATION IN OUR DATABASE WAS CONFIRMED BY SENDING A COPY OF EACH CUSTOMER'S INFORMATION SHEET ALONG WITH THEIR RENEWAL

NOTICES. THIS ENABLED CUSTOMERS TO ALERT US TO ANY CHANGES IN ADDRESSING OR INSURANCE COVERAGE.

SOUTH JACKSONVILLE FIRE DEPARTMENT PROVIDED RURAL FIRE PROTECTION TO 368 OWNERS, TENANTS AND BUSINESSES DURING 2010.

SUBSCRIPTION INCOME DURING 2010 WAS \$17,754.00. AN ADDITIONAL \$1,850.00 WAS COLLECTED DURING 2010 FROM FIRE RUNS TO INSURED PROPERTIES OUTSIDE THE VILLAGE LIMITS. A TOTAL OF \$19,604.00 IN REVENUE WAS GENERATED BY RURAL FIRE SERVICES IN 2010.

FROM 1987 TO 2010, OUR ANNUAL NUMBER OF RURAL FIRE CUSTOMERS HAS MORE THAN TRIPLED, GROWING FROM 100 TO 368 IN OVER TWENTY YEARS AND THE DEPARTMENT HAS SERVED OVER 3,000 RURAL FIRE CUSTOMERS.

OVER \$370,000.00 IN REVENUE HAS BEEN GENERATED OVER THAT PERIOD OF TIME.
